

# Are you paying your rates to the correct Council?

We've noticed an increase in the number of incorrect payments being made to both our Council and the Hawke's Bay Regional Council.

Central Hawke's Bay property owners pay two sets of rates - local rates to Central Hawke's Bay District Council and regional rates to the Hawke's Bay Regional Council. Please check your phone and internet bank settings to ensure your payments are going to the correct Council.

#### **Central Hawke's Bay District Council rates**

Rates are due on 20 August, 20 November, 20 February and 20 May. District Council Rates fund services to your property such as water, sewer, waste management, as well as amenities in your local community including roading, parks and reserves, libraries and community halls.

Central Hawke's Bay District Council's account number is 010777 0038665 00, please use your valuation number as reference.

#### Hawke's Bay Regional Council rates

The regional rates are invoiced annually in August and are due on 20 September. Regional Council Rates fund the management of natural resources on your behalf, such as water and air quality, land sustainability programmes, and coastal, wetland and habitat protection. The regional council also manages programmes such as flood protection, biosecurity, transport planning, regional economic development and regional civil defence emergency management.

Hawke's Bay Regional Council's account number is 020700 0010824 04, please use your valuation number as reference.

# Do you qualify for a rates rebate?

You have until the end of June to apply for the 20/21 Rebate, this application is based on your income year ended March 2020.

If you are receiving NZ Superannuation, WINZ benefits or your combined income is within a certain threshold, then you may be entitled to a Rates Rebate of up to \$655! See table below.

You must be living at the property and be the legal ratepayer on the 1st of July. When applying for the rates rebate you will need:

- Your District Council rates notice (Hawke's Bay Regional Council rates may also be included).
- · Details of your income (before tax) for the previous tax year
- Proof of your partner/joint homeowner's income if he/she lives with you.
