If the permission holder wants to continue to keep more than three dogs after the permission expiry date, they must request a new permission and pay the required fees before the expiry date.

5 This permission is given solely to the permission holder named above. It may not be transferred or assigned to anyone else. If the permission holder changes address a new dispensation application is required.

6 The dogs may only be kept on the property for domestic purposes. Adequate provision must be made for the dogs' hygiene, control, confinement and regular inspection, and for the protection of other people or property from being affected in any way by the dogs.

7 If any dog on the property dies, is sold, has pups or is transferred to a new property, written notification must be provided to the Council within 14 days.
