Am I eligible?

You may be eligible if you are the legal ratepayer for your property, and:

- · your property was your place of residence on 1 July 2024
- · your property is not used principally for commercial, industrial, business or farming purposes
- you apply between 1 July 2024 and 30 June 2025.

How much will my rebate be?

Your council will calculate your rates rebate. Your rebate amount depends on:

- · your rates amount
- · you and your spouse/partner's (if applicable) gross income, and
- the number of dependants living with you.
