## Declaration and conditions of permission

- Approval for dogs permitted to remain or be kept on a premises at any one time is limited to the dogs listed above.
- The Council may withdraw this permission by giving one (1) month's notice in writing to the permission holder at the address stated above.
- 3 The Council reserves the right to withdraw this permission at any time, without notice.
- 4 This permission expires at midnight on the expiry date set out above, unless withdrawn earlier by the Council. If the permission holder wants to continue to keep more than three dogs after the permission expiry date, they must request a new permission and pay the required fees before the expiry date.
- 5 This permission is given solely to the permission holder named above. It may not be transferred or assigned to anyone else. If the permission holder changes address a new dispensation application is required.
- 6 The dogs may only be kept on the property for domestic purposes. Adequate provision must be made for the dogs' hygiene, control, confinement and regular inspection, and for the protection of other people or property from being affected in any way by the dogs.
- 7 If any dog on the property dies, is sold, has pups or is transferred to a new property, written notification must be provided to the Council within 14 days.
- 8 All dogs kept on the property must be supervised and housed in such a manner that no nuisance to neighbours is caused by inadequate dog control, noise or poor hygiene standards.
